

Ashoka University's Board-Specific Policies

1. Indian Boards:

– Ashoka University recognises all boards approved by the COBSE. Please click [here](#) to view the complete list of boards recognised by the COBSE

-Applicants who have appeared for their final board examinations are required to submit the scores of all the subjects they have undertaken as a part of their class XII final board examinations

-In case an applicant is awaiting their final examination results at the time of filling in and submitting the application form, they are required to submit their predicted grades/scores. Predicted grades/scores are the estimated final grades/scores of the class XII board examinations. The predicted grades/scores may be provided by the school counsellor/any other relevant school authority. In the absence of official predicted grades/scores, applicants also have the option of submitting self-predicted grades/scores

-In case an applicant has received only grades instead of numeric scores in class XI and/or XII, applicants will have to submit a school-approved conversion scale for the Admissions Committee to be able to convert the grades into numeric scores

-Ashoka University follows the CBSE-prescribed scale for converting GPA to numeric scores in case of CBSE students -Ashoka University follows the COBSE-recommended scale to compare grades/scores across different Indian boards

2. International Boards:

-Ashoka University accepts students from all +2 level qualifications recognised by the [AIU](#).

-For International Baccalaureate (IB) students, applicants enrolled under the Diploma Programme (IBDP), the IB Course (Certificate), and the Career-Related Programme (IBCP) are eligible to apply for the undergraduate programme at Ashoka University. For Class X Middle Years Programme (MYP) students, the e-assessment is optional and applicants are not required to have taken it to apply to Ashoka University

-The IB Diploma Programme (IBDP) student has to secure a minimum of 24 credits with a minimum of three subjects at the Higher Level (HL), three at the Standard Level (SL), as well as a passing grade in the Extended Essay, Theory of Knowledge, and Creativity, Activity, Service (CAS)



-The IB Course (Certificate) Programme student has to secure a minimum of 24 credits with a minimum of three subjects at the Higher Level (HL) and three at the Standard Level (SL)

-The IB Career-Related Programme (IBCP) student has to secure a minimum of 24 credits with a minimum of 2 subjects at the Higher Level (HL) from the IBDP subject groups

-For all IB students (IBDP, Certificate, IBCP) who wish to pursue a Major in one of these four disciplines (Mathematics, Economics, Computer Science and Physics) at Ashoka University, the applicant should have taken one of the following subjects at the level mentioned: (1) Applications and Interpretation (HL) (2) Analysis and Approaches (SL or HL)

-For students enrolled in the Cambridge Board, applicants must appear for a minimum of 3 subjects at the A-level to be eligible to apply to the undergraduate programme at Ashoka University

-For all other boards, we request students to share a conversion sheet/normalisation scale or any detailing around the grading/scoring system used by the board/school authorities with the Admissions Committee
